## **NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Pension) (Second Amendment) Rules, 2017.
- (2) They shall come into force with immediate effect.
- **2. Amendment of rule 77.-** In rule 77 of the Rajasthan Civil Services (Pension) Rules, 1996,-
  - (i) for the existing punctuation mark " . " appearing at the end of sub-rule (iii), the punctuation mark " : " shall be substituted; and
  - (ii) in sub-rule (iii), so amended, the following proviso shall be added, namely:-

"Provided that a family pensioner, who is spouse of the deceased government servant and has been appointed in government service on compassionate ground under the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants Rules, 1996, after completion of period of probation, shall be entitled to get Dearness Relief on family pension or Dearness Allowance on pay whichever may be beneficial to him/her. The appointing authority of the government servant shall issue order for payment of Dearness Relief on family pension or Dearness Allowance on pay as the case may be and convey the same to the Director, Pension and Pensioners Welfare Department, Rajasthan, Jaipur and Drawing Disbursing Officer of the employee. In future if Dearness Relief on family pension is beneficial in comparison of Dearness Allowance on pay then Dearness Relief shall be payable and Dearness Allowance on pay shall not be payable. Similarly if Dearness Allowance on pay is beneficial in comparison of Dearness Relief on family pension in that case Dearness Allowance on pay shall be payable and Dearness Relief on family pension shall not be payable."
