NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules further to amend the Rajasthan Civil Services (Revised Pay Scales) Rules, 1998, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Revised Pay Scales) (Amendment) Rules, 2016.
(2) They shall be deemed to have come into force with effect from 01.04.2003.


2. Amendment of Schedule I.- At the end of section B of Schedule I appended to the Rajasthan Civil Services (Revised Pay Scales) Rules, 1998, the following shall be added, namely:-

3.	Reader Grade I (In the Court of District Court/ Addl. District Judge Court)	-	5500-9000	(11)	
4.	Senior Munsarim	6500-10500	8000-13500	(13)	The post of Munsarim is merged in the post of Senior Munsarim
5.	Process Server	750-940	2950-4475	(5)	
6.	Protocol Officer-Cum- Administrative Officer	-	10000-15200	(15)	
7.	Executive Assistant (In the Court of Principal District and Sessions Judge)	-	6500-10500	(12)	

NOTE:- Arrear of pay and allowances on account of revision/ upgradation of pay scale w.e.f. 01.04.2003 to upto the date of notification shall be deposited in the GPF account of the employee. The arrear to the employees recruited on or after 01.01.2004 and who are Governed by Contributory Pension Scheme, shall be paid in cash.”
